Is there a Connection between IRS Audits and Tax Return Extensions?

Some folks file for an IRS tax extension every year. An extension will give you 6 more months to file your Federal income tax return – although you must still pay any tax owed by the original due date (typically April 15th).

No one outside the IRS knows for sure how the audit selection system really works, but many CPAs have said that tax extensions may actually decrease your chances of getting audited. Some think there is a quota system and that these "quotas" are filled during March and April. Extensions miss this list.

Keep in mind, anyone who files for an IRS extension gets it with no questions asked. By filing for a tax extension, you are actually demonstrating compliance with IRS regulations.

So, in the future, if you need more time to gather your data... file for an extension and be ok with it.
