





Dollar Volume of U.S. Deals by Quarter⁽¹⁾⁽²⁾




Over \$4.3 billion in Q1 2022 in announced transaction value, approximately 80% of which came from PE deals



Q1 2022 U.S. Deals by Domain




The industry witnessed a focus on Online Learning and Corporate Learning, Certification & Recruiting domains in Q1 2022, which comprised ~55% of total transactions



Education Technology TEV / EBITDA⁽²⁾⁽³⁾




