Our family grew to 3! Meet Mozy, our Miniature Golden Retriever.

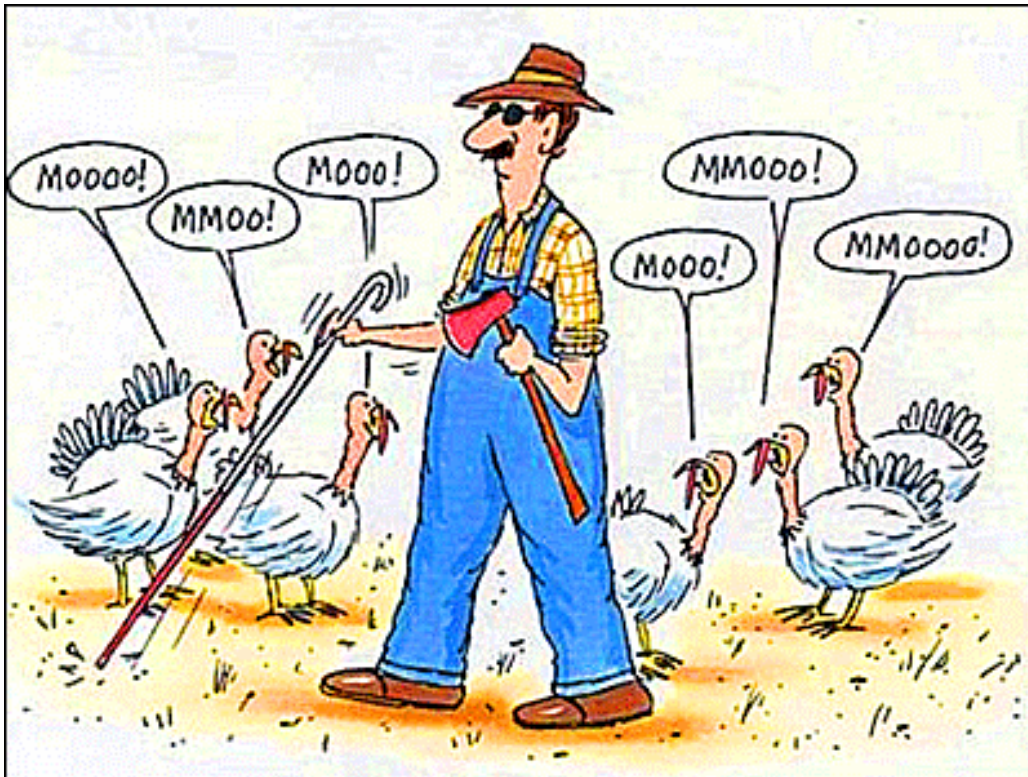
